The CCP E-Learning Programme

The Centre for Child Protection (CCP) develops a distance learning programme (E-learning) for the safeguarding of minors.

An interdisciplinary team of international experts is involved in developing a web-based education programme that offers the knowledge required to professionally and adequately relate to victims of sexual abuse and to their families and to act upon of safeguarding of minors.

The programme will be available in 6 languages: English, French, German, Italian, Portuguese and Spanish.



The Learning-Units

The units are sorted by thematic areas:

- Core Units
- Human Formation
- Theology
- Care
- Systemic Factors and Contexts of Abuse
- Intervention and Prevention

Each unit includes texts, videos, graphics and powerpoints and can therefore address different learning and educational needs.

Academic components and recommended readings are also provided for those who wish to implement the programme at an academic level.

Becoming a Partner

The E-Learning programme can be joined by Institutions – such as Universities, Congregations, Seminars, Dioceses, Schools, etc. By linking the E-Learning programme to their educational programme, these institutions become CCP partners.

The partners' institutions will be invited to choose units that are the most useful to their trainees and to combine them with face-to-face sessions organized and held by on-site trainers.

By doing so, each partner will be involved in adjusting the content of the E-learning programme according to its cultural, linguistic and legal context, and to its needs.
